THE INTERNATIONAL ISLAMIC UNIVERSITY MALAYSIA

The International Islamic University Malaysia (IIUM) was established in 1983, as an institution of higher learning by the government of Malaysia in accordance with the wishes and initiative of the Prime Minister, Dato' Seri Dr. Mahathir Mohamad. Added to it is a content of coursework in areas of Islamic Revealed Knowledge such as Qur'anic Studies, Hadīth Studies, Fiqh, Sīrah and Islamic History.
